MAE 'VAPES' ANGHYFREITHLON

YN ANNIOGEL

- Dim gwiriadau diogelwch na rheolaeth ansawdd
- Profion wedi canfod cemegion niweidiol a sylweddau sy'n gysylltiedig â chyffuriau fel **ketamin** a **spice** mewn rhai cynhyrchion anghyfreithlon
- Pecynnu'n aml wedi'i gynllunio i apelio at bobl ifanc
- Fel arfer â chryfder nicotin uchel (2% neu fwy) gyda thanciau rhy fawr (dros 2ml)
- Gall tanc 10ml gynnwys nicotin sy'n cyfateb i fwy na **7 pecyn o sigaréts**
- Pobl ifanc wedi adrodd bod angen iddynt adael arholiadau oherwydd dibyniaeth ar nicotin

CYSYLLTIAD

AG TROSEDDAU CYFUNDREFNOL

- Defnyddir gan grwpiau troseddau cyfundrefnol i wneud elw cyflym
- Yn aml yn cael eu gwerthu mewn siopau bach, stondinau marchnad, barbers, siopau vape, faniau a gwefannau hen eu rheoleiddio

SUT I ADNABOD

'VAPE' ANGHYFREITHLON

- Prisiau rhy rhad neu "rhy dda i fod yn wir"
- Diffyg rhybuddion diogelwch, manylion gwneuthurwr neu farciau DU
- Vapes tafladwy yn cael eu gwerthu er gwaethaf y gwaharddiad
- Dim gwiriadau oedran o gwbl
- Stoc wedi'i chuddio o dan gownteri neu'u gwerthu drwy DM ar gyfryngau cymdeithasol / tudalennau cymunedol
- Pobl ifanc yn ymddangos yn bryderus neu'n gyfrinachol o amgylch oedolion sy'n ymwneud â'r gwerthiant

MAE POBL IFANC YN CAEL EU TARGEDU

- Vapes rhad yn cael eu defnyddio i'w denu
- Rhai plant yn cael eu gorfodi i **werthu, storio neu ddsbarthu** vapes i oedolion - arwydd o gamfanteisio.

ILLEGAL VAPES ARE UNSAFE

- No safety checks or quality control
- Testing found harmful chemicals and drug-related substances like **ketamine** and **spice** in some illegal products
- Packaging often designed to appeal to young people
- Usually high nicotine strength (2% or more) with oversized tanks (over 2ml)
- 10ml tank can contain equivalent nicotine to **7+ packets of cigarettes**
- Young people have reported leaving exams due to nicotine dependency.

LINKED TO ORGANISED CRIME

- Used by organised crime groups to make quick profit
- Often sold in small shops, market stalls, barbers, vape shops, vans and unregulated websites

HOW TO SPOT AN ILLEGAL VAPE

- Very cheap or “too good to be true” prices
- Missing safety warnings, manufacturer details or UK markings
- Disposable vapes being sold despite the ban
- No age checks
- Hidden stock under counters or sold via social media DMs/community pages.
- Young people appearing stressed or secretive around adults involved in sales

YOUNG PEOPLE BEING TARGETED

- Cheap vapes used to draw them in
- Some are pressured to **sell, store or deliver** vapes for adults - a sign of exploitation
